# **Board Meeting Minutes (First Virtual Style Meeting) 16 April 2020**

A Board meeting of the Crooked River Ranch Rural Fire Protection District Board of Directors took place on Thursday, 16 April 2020 at 06:30 pm online using "ZOOM" meeting platform. This was due to the "COVID 19 Rules and Regulations" in place at the time.

#### **Board Meeting Minutes**

- 1. <u>Meeting Called to Order at:</u> 6:37pm by Director Oakley, She announced for the record that this was our very first ever virtual meeting.
  - 1.1. <u>Roll Call:</u> Barb Oakley, Brad Pahl, Jeff Green, Mark Wilson, John Meredith, Harry Ward, Sean Hartley, Dana Schulke, David McDonald, Marta McGovern-Philpott, Travis Delorto, Tina Wilson, Bill Burt, John Hayes and Warren.
  - 1.2. Flag Salute Led by- None.
- 2. Review of Agenda: No Changes.
- 3. <u>Approval of Board Meeting Minutes:</u> No March meeting due to the COVID 19 situation. Motion by Director Green to accept the February meeting minutes. Seconded by Director Meredith. Vote by roll call: Directors Oakley; Green; Meredith and Wilson voted Aye. Director Pahl voted Nay.

#### 4. Financial Reports:

- **4.1.** Director Green read the February financial report into the record. (See attached as appendix "A") Director Wilson made a motion to accept the February financials as presented. Director Pahl seconded. Roll call vote and motion passed unanimously.
- 4.2. Director Green then read the March financial report into the record. (See attached appendix "B") He stated all things balanced to the statement but he wanted to bring up a column that is mislabeled on our budget variance on the General fund paperwork. He asked Assistant Chief Hartley to look at the form titled General fund budget variance column number three on March and February. It is titled Year to Date Budget and that is not actually year to date but is the annual budget amounts. He explained that the year to date would be just the prorated amount for the year to date. Assistant Chief Hartley stated he would look into it. Director Pahl made a motion to accept the financials as presented and Director Meredith seconded the motion. Roll call vote and motion passed unanimously.
- 4.3. Board Members to sign checks in May on Monday the 11th and Friday the 22th. Director Meredith the 11th and Director Pahl the 25th. Director Green both signings.

<u>Comments from the Public on current meeting agenda:</u> This was not done due to the format of the meeting.

### 5. Unfinished Business:

Tabled.

### 6. New Business:

- **6.1.** Review of Budget calendar and the committee: Budget check list was in Board packet, along with Budget Committee Members names. The first meeting with the Fire Board is scheduled May 7th. The proposed budget document links are on the banner of the web site. More information will be sent out using the newsletter (Telegraph). There were questions and concerns about the March 30th proposed budget timeline being on track; the fact that our call volume was down; impacts to our financials by income being down due to the virus causing less calls as well as people not paying their taxes; income being down regionally and that other people are making adjustments for less income with the effects of this possibly lasting more than a year. Chief Ward addressed some of the questions and concerns.
- **6.2.** Discussion of Review of Resolution 2020-04 for appropriation received revenue from the Sale of Assets to Materials and Services by Chief Ward. There was a discussion of appropriate moving of funds and directly depositing them in the assigned line item. This is actually a transfer of funds from General Fund into Materials and Services and not a receipt of funds into the General Fund. There was discussion of how to sign this document. Director Meredith made the motion to pass 2020-04 and Director Pahl seconded. Roll call vote passed unanimously.
- 7. Fire Chiefs Report: (See last month's minutes for the report.) There were questions about the fence and the financials showing we had only paid a third of the bill and in the Chief's report it says the project is completed. The fence was completed and the payment went out on the 15th. Questions about airbags and CPR mannequins was if they had been purchased not by the district, but if the Volunteer Association had purchased them already. The Volunteer Association was going to vote on that decision. Questions about the delay on the new ambulance. The delay is due to lack of drivers. There was a concern brought up the necessity of having two Board Members in on the Union negotiations, rather than the Board being handed a document to sign at the completion of negotiations. There was a discussion including the concern of a conflict of interest by the Administrative staff to the Union staff. It was decided that Directors Oakley and Pahl would be involved in the negotiations.
- 8. Operations Report: (See last month's meeting minutes) Questions about no information on March numbers being in the report. The March numbers did not come in until after the report had been written. There has been tracking of everything purchased for the COVID 19 and will be submitted for reimbursement from the Federal Government.
- 9. Correspondence and Recognitions: The District received a letter from the Secretary of State office about the 2018-2019 audit. Director Oakley answered this letter last year at the direction of then President Bengtson, so she asked Assistant Chief Hartley about it and to see if there was any specific item in the audit that caused it. She had intended to bring this up at the March meeting but since we didn't have a March meeting she took it upon herself and just copied last year's letter and sent it in. Director Oakley then summarized a letter from the Tumalo Community Church offering to pray for us. She then read a letter from the PERS department thanking the Department for turning in all the required records on time.

There was also a "Best Practices" brochure from SDOA / SDIS for getting the education and other requirements to receive a discount on insurance premiums in the next year. The suggestion box at the station was empty. Chief Ward believes Tina Wilson is behind it, but they have received a lot of masks including N95 masks from the public. There was a comment made that we need to communicate in emails so the whole Board is getting the information to stay informed. It was brought up again the fact the Agenda was not received until Monday and that Volunteers and staff are receiving the Agenda on Friday. A question of why the Board does not get the emails at the same time as the rest of the department personnel especially ones that pertain to the Board of Directors.

- 10. Comments / Questions: None.
- 11. <u>Adjournment:</u> Adjourned the meeting at 07:40 pm. Question asked about having any Workshop meetings to address the Board Policies review. These will be pushed out for now. Next meeting May 7th for Budget Meeting.

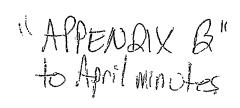

- 2. <u>Review of Agenda:</u> Director Wilson brought up unfinished business of 5.1. There was no reason for it other than receive a correct copy of the final print. It was removed.

### 3. Approval of Board Meeting Minutes:

**3.1.** Motion for April Minutes made by Director Green to accept the minutes as corrected. Seconded by Director Wilson. Roll call vote; NO votes from Director Oakley; Pahl and Meredith. Director Green and Wilson voted YES. Motion Failed.

#### 4. Financial Report:

- **4.1.** Director Green read the April financial report into the record. Director Pahl made a motion to accept the April financials as presented. Director Meredith seconded. Roll call vote and motion passed unanimously.

#### 6. New Business:

- **6.1.** Supplemental Budget Resolution 2020-05. Increase \$13500.00 for this year. Grant funds per Hartley have been stored by SAFER for several years waiting for us to ask for it. - **6.3.** Status of recovery of funds for COVID-19 from FEMA. Report from Chief Ward that we have spent \$871.00 so far and waiting for another invoice to submit everything. It can be submitted to the Feds or the State so Chief is trying to identify the correct avenue.
- **6.4.** Office hours update. Keeping the hours the same as they have been. Discussion about coverage and shifts to stay open 5 days a week. This will be reviewed in the future per Director Oakley.

Chief Ward added information about a phone meeting held by Central Oregon Health departments and first responders in regards to COVID-19. Director Pahl asked some questions about the collection agency and Chief Ward answered his questions. ## Fire Chiefs Report- June 2020

- The stairs have been installed in the Training building and now we are waiting for the railings to be built and installed. We have the materials for the decking that will go on top of the containers that we will be walking on. More materials will be purchased to work on the high angle rescue side, so we have a smooth surface to work on and put ladders up against. In the next month we should see concrete and other work being completed.
- Our pre planning of the commercial occupancies have been a little delayed due to COVID-19. Last week we started by completing our first one at our local water company. Because firefighter II students need to complete a pre incident plan, all 6 of the students will need to complete one. Our hope is that as we move further into the year that we will be able to have about half of the current commercial occupancies done by the end of the year. This data will drive how we respond to fires for commercial occupancies. Knowing how much water will be needed to put out a fire or "Fire Flow" will help us know how many tenders we would need for any of the occupancies down there. The other part of this preplanning is that we need to know how quickly we can get water from a fill site to the fire and back again. This summer will be doing a tender shuttle drills to start gathering the data on our turnaround times for buildings in the commercial area.
- Wildland season is hear and our response to conflagrations and task force responses might look a little different than in past years. Because of COVID-19 our crews will stay together and not be mingling with other crews. This will happen at the local and state levels.
- We will be starting back up with drills in the fire station starting Jun 22<sup>nd</sup>. This is a week away and we are working on protective measures to keep everyone safe. We will be using CDC guidelines as well as recommendations from SDAO when we are holding meetings. The main issue is the number of people we can safely have in the training room at once and still maintain a safe distance apart. Our goal is to have this all-in place by the Boards workshop in July.
- Our new students will be starting their academy on June 22 They will be starting out with wildland for the first week and then move right into structural fire training. Academy will be done in- house this year and we are looking forward to having them on board. Along with our students we have one volunteer that will be going through the academy as well.

▶ All the paperwork is completed for requesting funds from the Oregon Health Authority for Medicaid/Ground Emergency Transportation Provider billing. We will be receiving \$13,000 for cost reimbursement for uncompensated Medicaid cost that will be coming after July 1<sup>st</sup>.

- On Saturday, May 30<sup>th</sup>, a large thunderstorm hit portions of Crooked River Ranch. There were reports of high winds, hail, and a power outage. Within a 10-hour period after the storm the District responded to five (5) calls for service including one damaged structure and several public assists related to the power outage.
- ➤ The District has completed bringing on four student volunteers. They will be beginning their training academy on June 22<sup>nd</sup>. The academy will include wildland firefighter, structural firefighter, emergency driver, and technical rope rescue training. We will be following SDAO and OSHA recommendations for COVID protective measures.

- Chief Hartley and Chief Ward have been reviewing and planning for wildland fire responses in the current COVID environment. The Oregon State Fire Marshal's Office has released information on required PPE that will be needed to send apparatus and personnel to conflagrations. We are building kits for this purpose and are working with the local Emergency Managers to ensure enough PPE is available for both restocking after normal emergency calls and for conflagrations.
- Congratulations to Volunteers Garrett Schweigert, Nolan Wironen, and Jesse West! They are graduating from COCC. Garrett and Jesse will be finishing their Paramedic Internships to receive the Associates of Applied Science – Paramedicine. Nolan Wironen will be graduating with his Associates of Applied Science – Fire Science.
